Hi Erik,

I was contacted by our Legal Division regarding SCE's Application for Rehearing (AFR) on RAM that was filed back in January 2011:

This was filed before my time working on RAM, so I honestly wasn't aware that this was out there. Our Legal Division, in particular, wanted to know:

**“...wondering whether any of the IOUs have had to purchase any RAM contracts above the MPR, and if so, did any of them have to purchase them after their cost limitation was exhausted.”**

Based on the nature of this question alone though, it made me wonder whether PG&E believes that this AFR is still relevant. Can you check with your folks on this and let me know where PG&E stands on this AFR? If it is, in fact, no longer relevant, then I'd like to ask if PG&E could withdraw the AFR so that Commission Staff doesn't have to expend resources on disposal of it.

Let me know if you'd like to discuss this early next week.
