**Re: Withdrawal of Advice Letter 3188-E – Negative Indifference Amount Memorandum Account and Advice Letter 3188-E-A – Supplemental Advice Letter for Negative Indifference Amount Memorandum Account (NIAMA)**

Dear Mr. Randolph:

In accordance with General Order 96-B, Section 5.3, Pacific Gas and Electric Company (“PG&E”) hereby withdraws Advice Letter 3188-E<sup>1</sup>, which was filed on December 31, 2007, and its supplement, Advice Letter 3188-E-A<sup>2</sup>, which was filed on February 10, 2009.

The advice letters were submitted in compliance with Decisions (D.) 06-07-030, Opinion Regarding Direct Access and Departing Load Cost Responsibility Surcharge Obligations and D.07-05-005, Opinion Regarding Petition for Modification of Decision 06-07-030 Filed by Pacific Gas and Electric Company. Supplemental Advice Letter 3188-E-A also implemented certain aspects of D.08-09-012, which was a decision addressing non-bypassable charges for new world generation, among other things.

PG&E will submit a new advice letter which will revise the request PG&E made in Advice Letter 3188-E-A to align with Resolution 4226-E directives, which adopted the Power Charge Indifference Amount (PCIA) rates authorized in Decision 08-09-012. Resolution E-4226 was issued subsequent to PG&E’s request in 3188-E-A making the request inconsistent with the authorized rates.
