Pacific Gas and Electric Company (U 39 M) (PG&E) hereby gives notice of the availability of the Application of Pacific Gas and Electric Company for Authority, Among Other Things, to Increase Rates and Charges for Electric and Gas Service Effective on January 1, 2014 (Application), which PG&E filed with the Commission today, November 15, 2012.

The Application requests that the Commission increase gas and electric distribution and generation base revenue requirements by a total of \$1.282 billion, effective January 1, 2014, as compared to 2014 authorized and pending revenues, as well as such additional relief as the Commission may deem proper.

Pursuant to Rule 1.9(d) of the Commission's Rules of Practice and Procedure, PG&E is issuing this Notice of Availability because the Application and its supporting material, which include separately bound testimony and related workpapers, comprise several thousands of pages.<sup>1</sup> (PG&E intends to offer into evidence the workpapers, as well as the testimony.) The Notice of Availability is being served on all parties listed on the official service list for A.09-12-020 which is attached to the certificate of service for this document
