Late-Filed Exhibit ALJ-1 (Pipeline Modernization Program Capital Expenditures and Expenses Workpapers) should be revised due to a computation error. As a result, the total amount for the expense projects in Tables 1 and 3 should be \$337,810,000. This represents a reduction of \$571,000 or approximately 0.17% from the amount shown in the workpapers.
