Hello Working Group Participants,

Energy Division staff would like to say thank you to all the parties who submitted comments on the new Compliance spreadsheet. Attached, please find two zip files with all the comments received by Energy Division (one file for IOU/ESP and one for MJU). In addition to providing all of the working group members with the comments received, Energy Division staff would like to provide a brief explanation of how we plan to move forward with the new compliance spreadsheet. Currently, staff is reviewing your comments and making edits to the spreadsheet templates. Once Energy Division staff have completed editing the spreadsheets, we will redistribute the amended templates to the working group list for a second round of comments. Staff will provide working group parties with an extended review time (8-10 days) for the second round of comments, as Energy Division will not collect additional comments (from either the working group or the service list) before issuing the template for use. Staff intend to release the final version of the compliance spreadsheet sometime in mid-November, and collect the first 33% Compliance Reports before the end of December.
