**REPLY COMMENTS OF SOLARCITY CORPORATION  
ON COORDINATION QUESTIONS**

Pursuant to the Administrative Law Judges' November 6, 2012 Ruling Inviting Comments, SolarCity Corporation respectfully submits these reply comments to address issues raised by parties' opening comments.

**Other Proceedings and Legislation**

SolarCity believes the CPUC should track legislation related to rate design issues. At the same time, proposed legislation should not constrain or otherwise limit the rate design solutions that are considered in the Residential Rate Design proceeding. This proceeding should consider the full range of such solutions regardless of current or proposed statutory and regulatory limitations and restrictions.

**Coordination with Net Energy Metering**

The Commission has ordered the Energy Division to oversee the preparation of an updated net energy metering (NEM) cost-effectiveness study, which is underway. The Commission has indicated its intent that, subsequent to completion of the study, it will initiate a new rulemaking to reassess the NEM program in light of the study results. The results of such a separate NEM proceeding will be an important input to this Residential Rate Design proceeding, which should consider the impact of proposed rate designs on existing and prospective NEM customers. Contrary to the suggestion of some parties, SolarCity believes that rate design should be consistent with and complementary to the purposes of the NEM program, as established by

statute and Commission policy.<sup>1</sup> Furthermore, this Residential Rate Design proceeding should be coordinated with any future NEM proceeding.

**Conclusion**
