Subject: R.11-10-023 - Request for Extension of RA Comments Due December 20

ALJ Gamson and parties to R.11-10-023:

The current schedule in this proceeding calls for comments to be filed this Thursday the 20th in response to the December 6 Phase 2 Scoping Memo and Ruling of Assigned Commissioner and Administrative Law Judge. Attachment B to the Scoping Memo attached five pages of very specific and detailed questions pertaining to the Joint Parties Proposal in Attachment A. We note that the ISO has started a new stakeholder initiative named Flexible Resource Adequacy Criteria and Must Offer Obligations and that a recent Market Notice states that the process will begin with a stakeholder meeting on December 20 to discuss the straw proposal that was made available December 13. WPTF suggests that it would be very helpful to parties to be able to prepare for and participate in this stakeholder meeting prior to responding to the Attachment B questions. This is therefore a formal request that consideration be given to extending the response date by slightly over two weeks to Monday, January 7, 2013. Consideration should of course also be given to giving more time to Energy Division so that it can see parties' comments before finalizing its own proposal that is currently due on January 11.

If other parties would be supportive of this request, please indicate by responding on a reply to all basis. This is being sent in multiple emails to comply with server constraints.
