NOTICE OF EX PARTECOMMUNICATION

Pursuant to Rule 8.4(a) of the Commission's Rules of Practice and Procedure, Pacific Gas and Electric Company (PG&E) hereby gives notice of separate ex parte communications. The communications occurred on Monday, December 17, 2012, by voice message and by electronic mail at approximately between the hour of 10:00 a.m. and 10:30 a.m., to the offices of California Public Utilities Commission. The two email transmittals and its associated attachment are attached to this notice. [Rule 8.4(a), 8.4(c)]

John Hughes, Director, Regulatory Relations, PG&E, initiated the first communication with Carol Brown, Chief of Staff to Commission President Michael Peevey, and the second communication with Matthew Tisdale, Advisor to Commissioner Michael Florio. [Rule 8.4(b)]

Mr. Hughes left Ms. Brown and Mr. Tisdale voice message that PG&E had file its Reply Comments to the proposed decision issued by ALJ Galvin on Cost of Capital applications. He stated that PG&E took issue with the intervenor and DRA modeling results. Mr. Hughes said

that their modeling results were very low relative to several important benchmarks and their

results should be given little weight. He added that their results were unreasonable compared to

the national average. Mr. Hughes also addressed the claim by Southern California Edison (SCE)

that SCE's capital structure is more leveraged than PG&E's capital structure. Mr. Hughes stated

that there is record support that preferred stock should be treated as 50 per cent debt and 50 per

cent equity. As a result of treating preferred in this manner, SCE's equity ratio would be the

same as PG&Es. [Rule 8.4(c)]
