CONFIDENTIALITY DECLARATION FOR 2011 PRELIMINARY ANNUAL 33% RPS COMPLIANCE REPORT OF EDF INDUSTRIAL POWER SERVICES (CA), LLC

In accordance with the applicable reporting instructions, EDF Industrial Power Services (CA), LLC, an electric service provider ("ESP"), has caused the 2011 Preliminary Annual 33% RPS Compliance Report ("RPS Report") that is the subject of this Confidentiality Declaration to be submitted to the Energy Division and the presiding administrative law judges in the above-captioned proceeding. In addition, the submitting ESP has caused a public (redacted) version of the RPS Report to be served on the parties of record in the above-captioned proceeding.

Certain information contained in the submitting ESP's RPS Report, as specified in the table below, is eligible for confidential treatment under the provisions of Decision ("D.") 06-06-066 and the "Matrix of Allowed Confidential Treatment Energy Service Provider (ESP) Data" (the "ESP Matrix"), as modified by D. 08 -04-023, and the Commission is obligated to protect said confidential information so as to avoid material harm to the submitting ESP and/or its customers. Specifically, the submitting ESP's prior year's retail sales and the first three years of its forecast retail sales, as well as

certain RPS-eligible procurement/supply data (MWh) that could be used to derive such information, is eligible for confidential treatment—under the ESP Matrix—due to the fact that the submitting ESP does not own or control the output of any generation facilities and it generally procures the energy required to meet the demand of its retail customers through short-term transactions, thereby making its "net short" (as that term is used in the ESP Matrix) for any given year essentially equivalent to its total retail sales in that year.
