SUBJECT: Request to Establish the Conservation OII Memorandum Account

PURPOSE

This advice letter requests California Public Utilities Commission ("Commission") approval of a modification to GSWC's Preliminary Statement, Part P, to reflect the establishment of the Conservation OII Memorandum Account ("Memo Account"). The Memo Account will track unanticipated expenses of participating in Phase 2 of the California Public Utilities Commission's Conservation Order Instituting Investigation, pursuant to Decision No. ("D.") 08-02-036.

BACKGROUND

On February 29, 2008 the Commission issued D. 08-02-036, which authorizes a memorandum account for Class A water utilities to track legal and related expenses incurred in participating in the Commission's Conservation OII proceedings. Specifically, Ordering Paragraph No. 5 of Decision No. 08-02-036 states,

A memorandum account is authorized for Suburban and other Class A water utilities to track legal and related expenses incurred in participating in this proceeding from the date of issuance of this order instituting investigation (OII). Costs of preparing applications consolidated with this proceeding, whether incurred prior or subsequent to the issuance of the OII, shall not be tracked in the authorized memorandum accounts. Suburban's request to track legal and consulting expenses incurred prior to the issuance of this OII is denied.

MEMORANDUM ACCOUNT TREATMENT

GSWC is aware that a memorandum account is not a guarantee of eventual recovery of expenses, nor is it carried as a regular account under the uniform system of accounts for water utilities. It is carried "off the books", as a memorandum account. Further, it is also known that Commission policy on memorandum account treatment has always been that the burden of proof of the reasonableness of expenses charged to the account is the responsibility of the utility requesting reimbursement of such expenses.

REVISIONS TO PRELIMINARY STATEMENT

GSWC proposes to revise its Preliminary Statement to include Part P, Conservation OII Memorandum Account. The purpose of the Memo Account will be to track unanticipated legal and regulatory related expenses associated with GSWC's participation in the Water Conservation OII, Phase 2 proceedings. Disposition of amounts recorded in the Memo Account shall be determined in a subsequent regulatory proceeding, as authorized by the Commission.

TIER DESIGNATION

Pursuant to D. 07-01-024, this advice letter is submitted with a Tier 2 designation.

EFFECTIVE DATE

GSWC requests this filing become effective 30 days from its filing date.

PROTEST AND RESPONSES

Anyone may respond to or protest this advice letter. A response supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

- (1) The utility did not properly serve or give notice of the advice letter;

- (2) The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- (3) The analysis, calculations, or data in the advice letter contain material error or omissions;
- (4) The relief requested in the advice letter is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- (6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require re-litigating a prior order of the Commission.)

A protest shall provide citations or proofs where available to allow staff to properly consider the protest.

A response or protest must be made in writing or by electronic mail and must be received by the Water Division within 20 days of the date this advice letter is filed. The address for mailing or delivering a protest is:


Cities and counties that need Board of Supervisors or Board of Commissioners approval to protest should inform the Water Division, within the 20 day protest period, so that a late

P. CONSERVATION OIL MEMORANDUM ACCOUNT

(N)

Golden State Water Company ("GSWC") shall maintain a Conservation Oil Memorandum Account ("Memo Account") to track legal and related expenses in participating in the Commission's proceeding from the date of issuance of the Commission's Order Instituting Investigation (OII).

1. Purpose

The purpose of the Memo Account is to track legal and regulatory related expenses associated in participating in Phase 2 of the Conservation OII.

2. Applicability

The Memo Account does not have a rate component.

The Memo Account shall include:

The costs will include unanticipated legal and regulatory related expenses associated with participating in Phase 2 of the Conservation OII proceedings.

GSWC shall maintain the Memo Account by making entries at the end of each month as follows:

- a. A debit entry shall be made to the Memo Account at the end of each month to record the expenses discussed above.
- b. Interest shall accrue to the Memo Account on a monthly basis by applying a rate equal to one-twelfth of the 3-month Commercial Paper Rate, as reported in the Federal Reserve Statistical Release, to the average of the beginning-of-month and the end-of-month balances.

3. Effective Date

The Memo Account shall go into effect on the effective date of Advice Letter 1273-W.

4. Disposition

Disposition of amounts recorded in the Memo Account shall be determined in a subsequent regulatory proceeding, as authorized by the Commission.
