Commissioners- as part of our continuing discussions to resolve the outstanding PG&E enforcement proceedings, the following parties (Consumer Protection and Safety Division, Pacific Gas and Electric Company, Division of Ratepayer Advocates, The Utility Reform Network, City of San Bruno, and City and County of San Francisco) have agreed not to engage in ex parte communications with respect to the proposed decision on PG&E's Pipeline Safety Enhancement Plan in Rulemaking 11-02-019. The Proposed Decision is scheduled for vote on December 20, 2012.

We respectfully request that the Commissioners not engage in any communications regarding the PSEP PD with any party in the rulemaking. We also request that no all party meetings be scheduled.

The current record is thorough and detailed comments have been submitted and should stand without the need for ex parte communications. Honoring this request will allow the parties to dedicate their resources to continuing to work towards a beneficial outcome for the public, ratepayers, and shareholders.
