> Today, Greenlining Institute filed a Motion to Withdraw its Petition for Modification of D.12-05-015 (decision approving 2013-14 EE programs and budgets). Greenlining filed its petition on November 20th, 2012, urging the Commission to take up the question of background check policies for the utilities' energy efficiency contractors.

> · Greenlining have reached an agreement with PG&E on what both parties believe is a fair and reasonable background check policy, that addresses the critical concerns of customer safety and equitable access by all to jobs in this fast-growing economic sector.

> · Greenlining considers this agreement to be a mutual victory for both parties, and heartily commends PG&E on their willingness to engage with Greenlining and address the concerns of our communities.

> · They remain optimistic that Southern California Edison and the Sempra utilities will agree that PG&E's revised policy is fair and reasonable, and that they will adopt the same policy PG&E has, if they choose to adopt a background check policy.
