Hi Bill,

I spoke with Manho and his team this afternoon about the information regarding Moraga Potrero (M-P) that has been presented publicly. They directed me to the CAISO September workshops focused on reliability projects. However, we know that the comments you have due at the end of this month are related to the December workshops where the scope included renewable and economic projects (which is why M-P wasn't discussed in that deck). So it probably makes most sense to hold off on commenting on M-P until the draft plan comes out next month. Additionally, a good way to discuss the need associated with M-P is to note that SF is reliant on AC imports coming up the peninsula and the need to diversify this (in contrast to calling out Martin specifically).
