February 28 Commission Meeting

TO: PARTIES TO DRAFT RESOLUTION E-4550

Enclosed is Draft Resolution E-4550 of the Energy Division which initiates a citation program authorizing Commission Staff to fine public utilities for non-compliance with Permits to Construct (PTC) and Certificates of Public Convenience and Necessity (CPCN) issued for natural gas storage facilities; electric generating plants; electric transmission/power/distribution line facilities and substations. It will be on the agenda at the February 28, 2013 Commission meeting. The Commission may then vote on this Draft Resolution or it may postpone a vote until later.

When the Commission votes on a Draft Resolution, it may adopt all or part of it as written, amend, modify or set it aside and prepare a different Resolution. Only when the Commission acts does the Resolution become binding on the parties.

Parties may submit comments on the Draft Resolution no later than Thursday, February 14, 2013.

Comments shall focus on factual, legal or technical errors in the proposed Draft Resolution.
