Hi Dan: President Peevey supported a partnership between our regulated electric utilities (PG&E, SCE and SDG&E) and the Lawrence Livermore National Lab for research and development projects. On December 20, 2012, the commission, in a 5-0 vote, approved ratepayer funding for this 5-year partnership.
