**PACIFIC GAS AND ELECTRIC COMPANY'S SIXTH  
AMENDMENT TO RESPONSE FILED ON JUNE 20, 2011**

On June 20, 2011, Pacific Gas and Electric Company (PG&E) responded to the directives in the Order Instituting Investigation (OII). Appendix A to the June 20th Response reproduced the five chapters contained in PG&E's Initial Response filed on April 18, 2011, and added new Chapters 1A, 2A, 2B, 3A, 6A-D, 7 and 8. In addition to the chapters in Appendix A, PG&E filed over 16,000 records. Those records form part of Appendices B and C to the Response. Appendices B and C also included 11 indices (some with sub-indices) listing the records according to the chapter to which they most closely correspond. PG&E subsequently filed five amendments to its June 20, 2011, filing, on July 12, 2011, September 13, 2011, September 30, 2011, January 13, 2012, and March 19, 2012, all of which included additional responsive documents to the CPUC's OII directives.

This Sixth Amendment to the June 20, 2011, filing (Sixth Amendment) supplements Appendices B and C as follows:

(a) Additional Documents Responsive to Directive No. 2

PG&E's Sixth Amendment includes additional documents responsive to Directive No. 2, identified as Attachments P2-1478 and P2-1479. P2-1478 is Utility Operations (UO) Guideline G15001, titled "Gas Overbuilds." UO Guideline G15001 was in effect from August 2005 to October 2008, until replaced by Utility Work Procedure WP4100-04, also titled "Gas

Overbuilds,” effective October 2008. WP4100-04 and its attachments were produced in this proceeding in PG&E’s Response to CPSD Data Request 3-Q17, and are reproduced herein as Attachment P2-1479.

(b) Administrative Matters

Attachment A to this Sixth Amendment consists of an updated index for Chapter 2A.
