Pursuant to Rule 16.6 of the California Public Utilities Commission Rules of Practice and Procedure, Pacific Gas and Electric Company ("PG&E"), Southern California Edison Company ("SCE"), and San Diego Gas & Electric Company ("SDG&E") (collectively, "Joint Utilities") respectfully request a 30-day extension of the 90-day time period in Ordering Paragraph 9 of D.12-12-031 regarding filing a Tier 3 advice letter for approval of the Cooperative Research and Development Agreement, along with the proposed implementation plan and first year projects.

The Joint Utilities and Lawrence Livermore National Laboratory are making progress negotiating the Cooperative Research and Development Agreement and developing the business cases for the proposed research projects. However, additional time is necessary to complete these tasks. The Joint Utilities therefore request that the Tier 3 advice letter be filed with the Commission within 120 days of the adoption of D.12-12-031.
