**Subject:** RE: Granting Requests for Extension of Time to Respond to Protests of AL

Hello,

Following CPUC Staff's grant of SDG&E's request for a one-week extension to respond to protests to its advice letter 2428-E/2157-G (see below), the Energy Division received requests for a similar extension for Pacific Gas & Electric (ALs 3349-G/4158-E (Privacy Rules), and for Southern California Gas (AL 4433-G), which also encountered protests to their respective advice letters.

Because all of the IOUs face similar time constraints due to the holidays, and the Advice Letters are essentially consolidated for consideration, the requested extension may be applied to each of the IOUs that requests similar treatment.

Energy Division hereby grants an extension of one week to SoCal Gas, until January 10, 2013, to respond to the protests to Privacy Tariff Advice Letter 4433-G filed by Alliance for Retail Energy Markets/Direct Access Customer Coalition/School Project for Utility Rate Reduction. In addition, PG&E is granted a one-week extension, to Jan. 10, 2013, to respond to protests to ALs 3349-E/4158-G that it has received from EnerNOC, CCSF, and AREM/DACC/SPURR.

We have not received a similar request from Southern California Edison. If SCE wishes similar treatment, it should send an email to Energy Division analysts Alope Gupta ([AGS@cpuc.ca.gov](mailto:AGS@cpuc.ca.gov)) and Arthur O'Donnell ([aol1@cpuc.ca.gov](mailto:aol1@cpuc.ca.gov)) by 5 pm on January 3. Otherwise, SCE should respond to any protests it has received under the original timeline.

We also ask the IOUs to directly notify the protesting parties of the extension by referencing this email.
