We have very similar concerns about questions 2.1b and 2.1c. It seems highly unlikely that the average customer would possibly know how to answer the question, absent the education provided in section 3. Perhaps there could be some value in asking the question both before *and* after the education occurs to see how customer perceptions change? Either way, the way the question is phrased leads me to wonder, “what is meant by ‘work best for you’”? Doesn’t that really just mean “which of the following rates would (or *could* by implementing conservation strategies) result in the lowest monthly bill?” If this is the question, it is unclear how a customer could possibly answer with any certainty, absent the ability to compare each option *in detail* using his/her own energy data. As indicated by DRA’s comments, what would “work best” for a customer will certainly depend on the in-the-weeds details that are not provided by the generic options presented.
