Coming out of the meeting we had on Monday regarding the spreadsheet attached to Darryl's e-mail dated 12/6/12, we had the following action items to complete. I've indicated the status next to each one.

1. Review the hard-drive and verify, in writing, that DR3 Q6 is complete
