After diligent inquiry, we are unable to locate any correspondence in which CPSD had produced this MAOP list prior to Mr. Gruen's December 10, 2012 email.

In light of the above, please answer by December 28, 2012, the following questions:

Q 1: Did CPSD provide the attached MAOP list to PG&E prior to December 10, 2012?

If so, please provide a copy of the transmittal, including cover letter or email.

Q 2. When did Ms. Felts compile the MAOP list?

Ms. Felts compiled the MAOP list of documents found in PG&E's ECTS database in April in preparation to ask PG&E to print them. This was happening just as PG&E provided CPSD with save and print capability of documents in ECTS. CPSD used these new save and print capabilities for Ms. Felts to view the documents.

O 3. When did Ms. Felts transmit the MAOP list to CPSD?

To the best of CPSD's knowledge, Ms. Felts first transmitted the MAOP list to CPSD in December. Ms. Felts and Mr. Gruen each reviewed their respective records and did not find any evidence of Ms. Felts transmitting the MAOP list prior to that time.

Q 4. Did Ms. Felts intend the MAOP list to form part of her response to PG&E's DR 13, Ouestion 1?
