Sorry I've had to break up this email because of the number of recipients.

This ended up scheduled during a workshop on DG issues at the PUC (January 31, 2013
9:30 am – 4:30 pm: Renewable Distributed Generation (ALL technologies) Technical
Potential – Methodologies and Assumptions (Black and Veach/E3 sub) contract.), but time
permitting I will join the call.

I feel like it would be helpful to ask if respondents would prefer a rate mechanism that
provides a bonus/payment/bill credit if they can shift their average load off of peak (or
perhaps if they can "use less electricity during the middle of day than they do during the
rest of the day") with no penalty if they do not succeed in doing so. The questions in
sections 3 don't seem to get there. While such a mechanism could be argued to be a rate
structure, it's not clear that it isn't a potential element of multiple rate structures.
Regardless of that subtlety, I fear we are limiting the range of rate structures that can be
considered here by excluding this kind of question in the survey.

I think this is distinct from time of use, because it provides an explicit reward for changing
load profiles leaving rate structures free to remain the same or change if it becomes
preferable to do so. But clearly it's not a DR program or rate either because it's not peak
day focused. That does present a problem about how it would be integrated into the
structure you've presented here - perhaps it fits better in question 2, but unfortunately
people will not have had the benefit of understanding tier structures, etc. before hand if
placed there.

Good points. The same could be said about positive bill savings
 from switching from flat rates to TOU, absent any change in
 customers usage. If don't provide customer information about

potential bill impacts, they may think a rate such as TOU increases their bill when it fact it lowers it. It cuts both ways, but depends on the individual customer, their occupancy schedule, usage habits, and appliances/equipment at that particular home. A key challenge with choice surveys is that once the dollar impacts are presented, it tends to dominate all other attributes.

Two general comments/questions prior to tomorrow.

First – Why do the choice screens not provide exemplary monthly bills for the different rate structures, perhaps with and without load shifting? The presentation is structured and worded so that customers who think they can 'shift' usage would be led to believe they will 'save' money on any TOU rate, and would thus likely choose the TOU rate. But I do not see any explanation that if they 'cannot' shift, the total bill could increase under TOU relative to flat or tiered. This seems a biased result. I think the conjoint choices should include some information re. relative bill impacts, otherwise people are just guessing. And in fact, they are not guessing since it is impossible for them to conclude anything about their bills from the actual choices. Their choice will thus be entirely driven by their reaction to the description of the different rate types. This description ignores any possible negative *relative* bill impacts of TOU v. flat v. tiered.

Second, I am concerned about the stability/low bill tradeoff issue. There is only one subquestion addressing the desirability of 'stability.' There is no information (or I missed it) on how different tiered rates or TOU rates might impact monthly bill volatility. There is significant market research (and actual market data) showing customers strongly value monthly bill stability. How is this incorporated into the survey?
