Hello Everyone,

Some errors have been discovered within the Padilla Report template, and Energy Division staff would like to issue a corrected template (please see attached). Any/all changes in the report columns have been highlighted in orange and are listed below:

2012 Contract and Generation Tab

- *Column E* – “California Energy Commission (CEC) – RPS ID Number” – Please make sure to use the CEC RPS ID. Don’t use the CEC plant ID (as used in the shortform report).
- *Column F* – “Technology Type” – This is an added column to the Padilla Report template. Please use the standard technology classifications, as used in the PDSR.
- *Column H* – “Contracted Capacity Min (MW)” – For feed in tariff projects or other contracts with a minimum capacity of zero, please use the Expected Energy value (as in the PDSR).
- *Column M* – “CPUC Approval Date” – This is an added column to the Padilla Report template. Please enter the date which the contract was approved in the PDSR (MM/DD/YYYY).

2012 UOG Tab

- *Column G – “UOG Technology Type”* – This is an added column to the Padilla Report template. Please enter the technology type for all UOG projects.
- *Column H – “Expected Project Size (MW)”* - This is an added column to the Padilla Report template. Please enter the expected capacity (in MW) for all UOG projects.

General Notes/Clarification

- Within the 2012 Contract and Generation Tab, please enter all projects that generated energy in 2012, and all projects that were CPUC Approved in 2012. You do not need to include contracts that are pending CPUC approval, or contracts that do not require CPUC approval (contracts labeled as “No Approval Needed” in the PDSR)

The data request for the 2012 Padilla Report is still due on **Thursday, January 17, 2013**. If you have any further questions regarding the Padilla Report data request, please feel free to contact me.

Subject: Energy Division Data Request Seeking Information pertaining to Senate Bill (SB) 836 (Padilla, 2011).

Hello Everyone,

Energy Division staff is requesting information related to all RPS costs (including UOG and IPP projects) incurred between January 1, 2012 and December 31, 2012. RPS cost figures should be reported per project basis, and should include contracts executed in 2012 that have not yet achieved Commercial Operation. Please respond to this request by **Thursday, January 17, 2013**.

Information provided from this request will be published within a follow-up/supplemental appendix for the Energy Division 2012 3rd and 4th Quarter RPS Report to the Legislature, and presented to the California Legislature no later than Friday, February 1, 2013. All figures will be presented in aggregate form as required by SB 836. Specifically, the figures will be presented on a per IOU basis for each year the contracts were signed for each technology category and project size threshold in which three contracts were executed.
