Jeff and Shilpa,

As I discussed with you both during our recent phone conversations, I recently spoke with Mr. John Larrea, Government Affairs Director for the California League of Food Processors. This is an organization that represents many food processors who have operations throughout California that could be adversely affected from service disruptions from future CPUC initiated activities related to gas transmission pipeline testing and replacement projects. Mr. Larrea requested to have his organization included on any listings that PG&E or Sempra (Companies) are maintaining and using to inform large industry organizations of events and issues that impact their members.

We are well aware that the Companies work with their individual large industrial customers to communicate and schedule pipeline work in a manner that minimizes impact to the customer and limits or avoids service disruptions. However, it's not as clear what activities the Companies do to communicate service disruption issues, perhaps on a higher level, to the larger

organizations representing the Companies' large industrial customers. We request that the Companies provide details on any planned process for communicating future testing/replacement activities to larger organizations. Specific to Mr. Larrea's request, please let us know if his organization is already included in any listings your company maintains and what your company intends to do to touch base with Mr. Larrea and communicate to him what your company may be able provide to keep his organization more informed on future gas pipeline testing and replacement activities affecting its membership.
