To All Parties in I.12-01-007, I.11-02-016 and I.11-11-009,

On February 25, 2013, the Division of Ratepayers Advocates (DRA) filed a Motion for Public Disclosure of Confidential Testimony and Related Discovery Responses Regarding PG&E's Ability to Absorb Fines and Other Costs Related to Its Gas Transmission Operations. In a ruling issued yesterday, ALJ Yip-Kikugawa shortened the time to respond to DRA's motion to noon on Wednesday, February 27<sup>th</sup>. DRA's motion seeks to have all financial testimony, as well as supporting documents produced in discovery and related discovery responses, that have been designated as confidential be made public. We cannot rule on DRA's broad request without first reviewing the documents in question. Evidentiary hearings in the above proceedings are to begin on March 4<sup>th</sup>. Pursuant to Rule 13.1(a), we therefore find that public necessity requires hearing on DRA's motion this week.
