Comments on the January 23 workshop and Energy Division proposals in R.11-10-023 are currently due on February 13, with Reply Comments due on February 27.

There have been delays in providing the transcript for the January 23 Workshop. This should be resolved very soon.

Energy Division intends to provide an update to its proposal regarding flexible capacity, expected approximately Feb 28. This will be provided to parties via a Ruling seeking comment.

For these reasons, I am delaying the due date for comments.

Comments will now be due on March 15. Reply Comments are now due March 29.

I will either confirm these dates in the upcoming Ruling with the Energy Division updated proposal, or modify the dates as appropriate.
