Subject: CPUC Update RE: R.12-06-013 IOU Bill Calculator Model Status

To the Service List for CPUC proceeding R.12-06-013:

The Energy Division would like to update the parties on the process going forward for completing the bill-impact calculators. In short, we are moving from development/iteration stage into the testing/validation stage with the goal/aim of having the models completed and ready for use in this proceeding by the end of February. That date is not firmly set in stone, but it appears to be feasible. At the end of the process the Energy Division will communicate to the parties when the models are ready for use in this proceeding.

- Parties have now received PG&E's calculator and we expect SCE and SDG&E to release their calculator next week. We encourage parties to get familiar with the models, start testing them, confirm if the models are working properly and whether the output displays are usable for this proceeding.
- Each IOU will hold at least one webinar to demonstrate their bill impact calculator, answer questions and address any technical issues if identified.
- Following the webinars there will be a brief period for written comments on the above points.
- If final changes are needed based on the above process, the Energy Division will indicate when the models are ready for use in the proceeding.

Stayed tuned for scheduling updates from the IOUs as they post their calculators.
