Thank you to those who participated in SCE's Res. Rate Bill Calculator webinar on Friday. The following items are a recap of the updates that will be made for a model to be released prior to Friday, March 8th:

- Include a histogram to view bill impact by income
- Provide NEM customer bill impact model (either inside the current model or separately)
- Enhance the TOU overly option to allow a user to input an on-peak surcharge and the model will calculate a revenue neutral surcredit
- Update the marginal cost assumption for design demand
- Minor labeling/typo cleanups
