The Energy Division expects the IOUs will release the final Bill Impact Calculators by March 8. The Energy Division will confirm when the Bill Impact Calculators are ready for use in this proceeding.

When making final comments on the Bill Impact Calculators:

- Consolidate comments into one document if possible when commenting on more than one calculator.
- Type of comments that we encourage at this time include:
  - Inclusion of functionality previously agreed to, but not yet included in the calculators;
  - Technical issues with the function of the model;
  - Improvements in formatting and printing; and
  - Changes that would not delay the release of the Bill Impact Calculators beyond March 8, 2013
