I will ask Kay or Carmen to forward you the contracts with our evaluation contractors. I apologize for the delay on this – I believe I actually dropped this ball because when I looked into this last fall, I was told that we had previously sent these contracts to relevant utility EE program and/or eval managers on multiple occasions.

And thank you for the standard contract “strawperson.” I believe we did use this (or its precursor, if this is a relatively new version of the document) as a basis for the agreement we currently have in place with our contractors. I was not able to attend all of the data center workshops, but what I caught was quite interesting. There were quite a few troubling anecdotes shared about challenges that local government and educational/research institutions have been having getting access to data they need to do their work, and the debilitating impacts on their IT budgets of complying with utility security provisions.

Thx Pete for your email and letter today. I'll check with PG&E Reg Affairs and our program managers on our schedules for a meeting to discuss your letter and let you know, and thanks for the update on the CPUC's recommended approach.

In addition, may I have our program leads call you directly to get some additional details on the ex ante review team's problems listed in your letter, including the "missing project" info problem, so that they can address any of those technical "streamlining" issues before our meeting?

Also, can you please let us and the other IOUs know when we will get copies of the CPUC's contracts with its consultants that was one of the action items in our September 26 meeting with Frank Lindh and staff last fall? (See email below.) As we discussed and agreed back on September 26, it would be useful to have copies of those contracts, including the information security and privacy provisions, prior to the followup meetings the CPUC staff committed to set up then.

Also, per your request for our thoughts on the CPUC's NDAs with consultants and "best practices" on privacy and information security protections you may want to include in your own NDAs with your consultants, attached is the "strawperson" standard data sharing agreement PG&E provided to CPUC staff, ALJs and interested parties at the CPUC's recent "energy data center" workshops a couple weeks ago. Exhibit B of this standard agreement may be useful for your consideration and for our followup discussion.
