We are getting phone calls daily from NRG's Sean Beatty asking about the Contra Costa AL . The connection between the Advice Letter and Marsh Landing's power plant is entirely unclear. There is no mention of the powerplant in the Advice Letter so other than the fact that customers and generators are inconvenienced by outage times, I do not see the connection between the powerplant and your pending Advice Letter. To be honest, the whole daily calls from NRG is confusing the situation - and making us need to wonder if you actually stated the true purpose of the project in the Advice Letter. If the AL is to serve NRG, it certainly is never mentioned in print.

Can you please advise.

Meanwhile, we are moving forward slowly but surely....
