**NOTICE OF EX PARTE COMMUNICATION

Pursuant to Article 8 of the California Public Utilities Commission (“Commission”) Rules of Practice and Procedure, Morongo Power hereby files this notice of the following oral ex parte communication with Matthew Tisdale, advisor to Commissioner Mike Florio, and with Damon Franz, advisor to Commissioner Peevey.

On February 6, 2013, Morongo Power representatives met from approximately 11:00 a.m. to 11:30 a.m., with Mr. Franz, and from approximately 11:30 a.m. to 12:00 pm, with Mr. Tisdale, at the Commission’s offices in San Francisco. Morongo Power was represented by Roger Meyer, Chief Executive Officer, Morongo Band of Mission Indians (Tribe), Sean Gallagher, Managing Director for Morongo Power, and Tom Tureen of Morongo Power. During the meeting, Mr. Meyer explained the Tribe’s business interests, Mr. Tureen described the joint venture between the Tribe and K Road Power which created K Road Power, and Mr. Gallagher explained why the proposed decision authorizing long-term procurement for local capacity requirements should be revised to provide SCE with the flexibility to procure effective resources throughout the LA local reliability area, and to take into account the viability of proposed resources within the local reliability area.
