## Residential Rates OIR Parties:

As a follow up to the release of the Customer Survey Draft B last Friday, we would like provide an explanation of how we processed the red-lined comments that were provided by some parties in this proceeding .

There were a very large number (over 200) of suggested changes to the survey from other parties, many of them overlapping and / or conflicting. Although we were not able to accept every suggested change, we made substantial effort to consider every comment that was provided.

Attached is the “Discussion Topics” document that was shared at the January 31<sup>st</sup> webinar with the parties. It has been augmented with a list of some of the most substantive changes that were made to the Customer Survey Draft B based on the red-line feedback from other parties. In addition, there are explanations of why some suggested changes were not incorporated.
