We hope you find the flexibility, understandability and intuitiveness much improved over what we had initially discussed. In addition SCE has added a new "Help" tab that explains functionality, however will also produce a manual and provide a webinar to review the model next week. This model will also be supplemented by a NEM specific bill impact comparison, which we plan to release in about one week.

SCE is providing this model for the limited purpose of examining alternative proposed residential rate designs as part of CPUC proceeding R.12-06-013.
