The requested rate of \$200/hr is reasonable in light of Mr. Culley's experience and is consistent with the rate guidelines for similarly qualified attorneys in Resolution ALJ-281.The Commission approved a rate of \$185/hr for Mr. Culley, as a first year attorney, in D.12-04-042 (issued April 27, 2012). An increase of \$15/hr is reasonable to reflect Mr. Culley's additional year of experience since that time.
