Thx James for your update. As Pouneh Ghaffarian and Pete Skala of the CPUC know, we are awaiting a meeting with CPUC staff to discuss "best practices" for privacy and information security contract language that is a followup to a meeting the IOUs had with the CPUC staff last fall in which the CPUC requested the IOUs' recommendations for such "best practices" in their contracts with consultants and agreed to share with us the CPUC contract language.

If the confidentiality language in the CPUC-Navigant contract is the same as the language that CPUC staff recently sent us relating to the CPUC's contracts with other consultants, the language is not consistent with the "best practices" language PG&E has recommended to Navigant nor the revisions to that contract language that Navigant proposed to PG&E this week, which revisions are generally acceptable to PG&E and consistent with similar agreements we have with Navigant and other consultants accessing customer-specific data.

We defer to the CPUC and Navigant on whether to incorporate these "best practices" into the CPUC contract, and look forward to discussing our recommendations with the CPUC in the followup meeting requested by Pete Skala. Thank you to Navigant for working with us on this proposed contract language on privacy and information security.
