See Redacte note below. Note that PDP (peak-day pricing, our name for CPP plus TOU), is a add-on rate, and sits on top of the TOU rate they are on. So, when they opt out, they go either to the TOU rate, or to a DR program.

Hi Sid,

[Redact] confirmed the following stats (Thank you [Redact]). It's important to note that these counts represent active accounts only, and do not include those accounts that are now closed. I can get those stats if you feel it offers a more complete picture.

Counts are for service agreements, and not individual customers (that will be lower) through January month end:

5,876 current participating SAs on PDP (63% of eligible)

1,408 are Large C&I,

201 are Medium C&I,

4,112 are Small C&I (mostly Comcast billboards & AT&T),

110 are Large Ag,

21 are Medium Ag and

24 are Small Ag.

Of these 5,876, 1,055 were automatically defaulted and another 4,819 optionally enrolled or affirmed/acknowledged their impending default.

Yes – customers can opt-out of PDP at any time without penalty.

Of the 9,393 active Service Agreements eligible for transition to PDP, 3,432 (37%) are now “inactive” on PDP with 23% having opted out, 13% having unenrolled post transition and 1% being disqualified for PDP (due to net metering, DA or incompatible DR Program).

Large = >200kW

Med = >75 kW but less than 200kW

Small =<75 kW
