Please note that Energy Division staff reviewed prior versions of the PDSR template, and have taken the liberty of removing some of the lesser used fields (e.g. Secondary Developer Website, Site Owner, EIR Lead Agency, and others). Additionally, staff have added three new fields and amended one of the existing dropdown menus, in order to help us with our data needs. The new fields added are: Overall Status, Expected PCC Classification and Point of System Interconnection. Staff have amended the drop down options for the "Contract Type" field to remove outdated classifications, and include new classifications for the different RAM auctions.
