After the file has been saved to your computer, please enable editing and macros to view the bill calculator.

Along with the Bill Calculator Model, we are providing an Electric Bill Calculator User Guide and a Bill Calculator Model Methodology document.

Per a conversation with Energy Division on Wednesday, March 13, the following additional changes were incorporated into the model:

1. Output tabs that change with the results of the rate designs have been color coded as purple.
2. A print macro has been added in the "Summary" tab that allows printing of all relevant inputs and outputs of the model.
3. Labeling changes have been made in the Energy Conservation Tab. Also, summary outputs have been added in the top area of this tab.
4. On the "Summary" tab, we have added the Step numbering as a label on the button.
5. We have included explanation of source of input data and how it's derived in the Manual.
6. We have added the count of customers in each poverty level range in the manual.

This model replaces any version used prior to today's date, March 18, 2013.

We do not anticipate releasing any additional versions of the model after today and will await approval of this version by the Energy Division.
