I want to provide you with a brief update on the progress we've made in staffing the leadership team in our Safety Department. We have more work to do in strengthening the team but I am pleased to report that we now have a strong and capable senior team in place to help us build a high performing Safety organization.

**Steven Fischer** joined us on January 7 as **Director, Public Safety Strategy**. Steve comes from 16 years with the U.S. Department of Transportation, Pipeline & Hazardous Materials Safety Administration (PHMSA), Office of Pipeline Safety.
