Attached is the agenda for the March 26, 2013 workshop concerning the application required to be filed by PG&E pursuant to Ordering Paragraph 11 of D.12-12-030.

Also, in preparation for the workshop, please note that D.12-12-030 refers to the application PG&E is to file as an "expedited application" (D.12-12-030, p. 115). D.11-09-006, issued in R.11-02-019, provides an example of the procedures the Commission has used to expedite an application. That decision adopted procedures for lifting operating pressure restrictions on PG&E pipelines. It may serve as a model for PG&E's update application and can be further discussed at the workshop.
