Pursuant to Commission Rules of Practice and Procedure 11.6, this e-mail requests that the parties agree to a 14-day extension for opening and reply comments on Track III Rules Issues in the LTPP proceeding, R.12-03-014.

Instead of April 12, 2013 and April 26, 2013, opening comments and replies would be due on April 26, 2013 and May 10, 2013, respectively. DRA makes this request because the same individuals working on Track III are also working on the Resource Adequacy proceeding, R. 11-10-023. In that proceeding, opening comments on Phase 2 issues are due on April 5, 2013 and replies on April 15, 2013. On April 3, 2013, the CAISO will hold an all day workshop on flexible resource adequacy criteria and must offer obligations. Comments on that workshop are due on April 10, 2013. Additionally, on April 4, the CAISO will hold a workshop from 10:00am to 3:00pm on RA local capacity requirements with comments due on April 18, 2013. The two week extension of the Track III comment due date will allow the parties to meaningfully participate in the Resource Adequacy proceeding and to prepare comments that adequately address the numerous and complex issues in Track III.

Rule 11.6 requires that before requesting an extension from an Administrative Law Judge, a party contact all of the other parties in the proceeding and "make a good-faith effort to ask such parties to agree to an extension." Please let me know by 4:00 pm today, March 25, if you support or oppose an extension. I will then send an email to ALJ Gamson requesting a 14 day extension and indicating which parties support or oppose the request.
