> These guys at PG&E are something.

> After assuring us that nothing was going to be filed publically about our

> PPA termination, they sent us this email below very late this afternoon (see

> below) and informed us that they were filing this with the CPUC tomorrow. In

> addition the press has already asked questions about it.

>

> From PG&E:

> "I want to let you know that we will be filing our Project
> Development Status Report (PDSR) with the CPUC tomorrow. In that filing we
> will be required to show Solaren as terminated. This is a public
> document that will be posted on the CPUC website. Additionally, a reporter
> has contacted our news group asking for a status update on Solaren.
> We will need to provide this same public info to him. Thanks and let me know
> if you would like to discuss".
>
> What is particularly disturbing and disappointing to us is that we have been
> negotiating in good faith a new PPA with PG&E for the last 45 days with the
> intention of re-filing the PPA in April, after we close our stock offering.
> We asked PG&E if they would mention that PG&E and Solaren are currently
> negotiating a new updated PPA, but PG&E said they could not mention
> anything, because of confidentiality (Solaren's?). We are actually
> extremely close to finishing. We're very close on price and just need to
> set a final number, and we're negotiating when the new 2nd deposit would be
> due. We have basic agreement on the 2nd deposit, and our counterparts have
> started the process of getting the approval of PG&E senior management. PG&E
> has filed for an "independent evaluator", but one has not been provided yet.
> I believe this is the person that provides an independent assessment of the
> negotiations and provides a report to the CPUC, PG&E, and us, among others.
>
> Next week we are meeting with several investors willing to invest multi-\$M
> in Solaren. We and they have been working towards this since last summer.
> They are flying in from Asia. The timing of this announcement could not be
> any worse. One of the key reasons for the PPA in the first place was to help
> us get funding for this first of a kind system.
>
> We also asked them if they could file the termination in 45 days (mid-April)
> after we re-filed our PPA, but no success there either.
>
> Sorry to vent Mike, but these guys just get to me at times.
>
