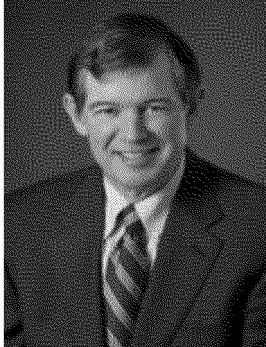


Anthony F. Earley Jr.
Chairman, Chief Executive Officer and President
PG&E Corporation



Anthony F. Earley Jr. is Chairman, Chief Executive Officer and President of PG&E Corporation. Earley joined PG&E in September 2011 after 17 years at Detroit-based DTE Energy, where he served as chairman and chief executive officer for 12 years, before becoming executive chairman of the board in September 2010.

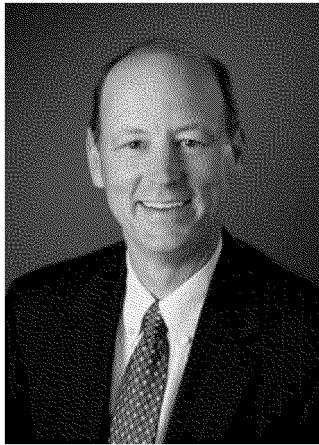
As former chairman of the Edison Electric Institute, the trade association of investor-owned utilities, Earley was directly involved in the development of national policies on energy, the environment and climate change issues. Earley also served as chair of the Nuclear Energy Institute and worked to revitalize the nuclear industry in the United States.

Earley earned a Bachelor of Science degree in physics, a Master of Science degree in engineering and a law degree at the University of Notre Dame, where he serves on the advisory council of the College of Engineering. After graduating from Notre Dame, Earley went on to serve as an officer in the United States Navy nuclear submarine program, where he was qualified as a chief engineer officer. He joined DTE Energy as president and chief operating officer in March 1994. Prior to joining DTE Energy, Earley served in various capacities of increasing responsibility at Long Island Lighting Co., including president and chief operating officer and executive vice president and general counsel.

Earley serves on the executive committees of the Edison Electric Institute and the Nuclear Energy Institute and is a board member of the Electric Power Research Institute. He is on the board at Ford Motor Company and serves on the listed member advisory board for the New York Stock Exchange. In the past, he has served on the boards of Masco Corporation, Comerica Bank and Mutual of America Capital Management.

His commitment to the community includes memberships on the boards of United Way Bay Area and The Exploratorium, a science, arts and human perception museum based in San Francisco. His community service has also been recognized by The Detroit News, and in 2003 he was selected as one of several Michigianians of the Year.

Christopher (Chris) P. Johns is President of Pacific Gas and Electric Company and a member of the utility's Board of Directors.

Johns joined Pacific Gas and Electric Company in 1996 as Vice President and Controller. Johns was named Senior Vice President and Controller of PG&E Corporation in September 2001 and elected Chief Financial Officer in January 2005. He was named President of Pacific Gas and Electric Company in August 2009.

Before joining PG&E Corporation, Johns was a partner in KPMG Peat Marwick LLP.

Vice President, Customer Energy Solutions



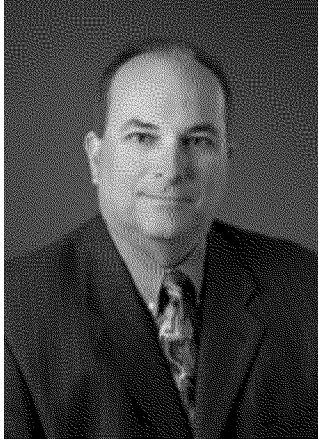

Vice President of Customer Service

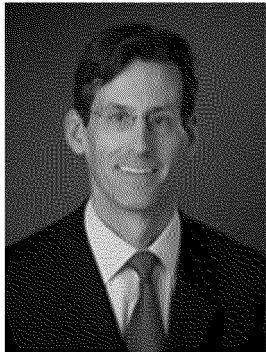


Laurie Giammona is the Vice President of Customer Service at Pacific Gas and Electric Company (PG&E).

Executive Vice President, Electric Operations



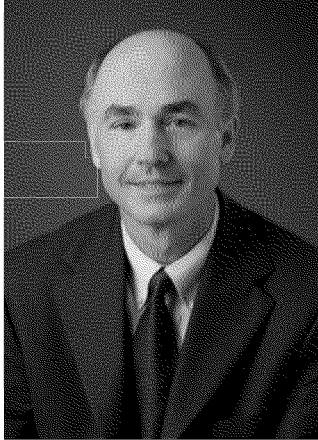

Senior Vice President, Safety and Shared Services

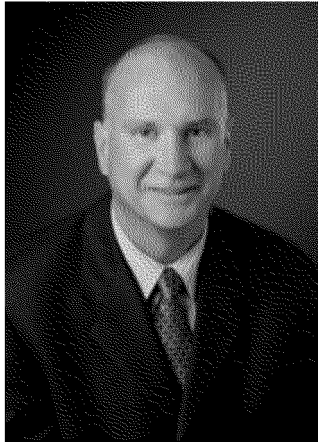

Conway is the Chairman of the board of directors for Fuelco, LLC, and serves as the Chairman of the Nuclear Energy Institute Executive Fuel Task Force.

Prior to joining Pacific Gas and Electric Company as the site vice president at Diablo Canyon in May 2007, Conway served as site vice president of the Monticello Nuclear Plant in Minnesota. He spent 24 years at Nine Mile Point in Oswego, New York, where he held a series of positions of increasing responsibility, including the senior executive role at the station, site vice president, vice president of Nuclear Engineering, plant manager and operations manager. He also served as the power ascension manager for the initial startup testing program for Nine Mile Point Unit 2.

Conway holds a mechanical engineering degree from the University of Rochester in Rochester, New York. He held Senior Reactor Operator licenses for each of the two different nuclear units at Nine Mile Point and has graduated from the INPO Senior Nuclear Executive Seminar and the INPO Senior Nuclear Plant Manager Course.

Executive Vice President, Gas Operations

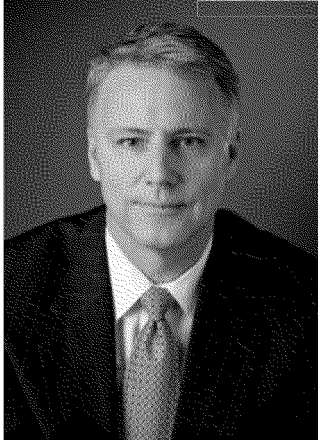
