Julie,

A few questions regarding next Tuesday:

- When we had these meetings with the other Commissioners, the discussion with Tony and Chris included only the Commissioner. Would Commissioner Peterman like to take the same approach? We could have you and the Commissioner participate in that meeting and then the rest of the staff join at 10.

- The plan for the Customer Care overview is to have the officers very quickly discuss their areas of focus, including EE and DR and spend the majority of time on the Analytics and Research Tool. This data tool is used to find commercial and residential customers that would be interested in EE projects and SmartRate based on demographic and usage information. The tool is cutting edge and could be used in the future for other conservation products. Would Commissioner Peterman be interested in learning about this tool? We can then incorporate Smart Grid and distribution planning in the Electric Ops briefing rather than tour the transmission control center.

- Since Commissioner Peterman met with members of our Energy Supply team previously, we propose shortening the Energy Supply discussion rather than eliminating the gas

briefing. We can also definitely schedule a separate gas briefing, but feel it would be beneficial for Commissioner Peterman to meet Nick Stavropoulos now and then have a more in depth discussion on gas at a later date. This approach would allow us to conclude by 4:00. If that is not early enough, we could skip gas altogether as you suggest and end the day at 3:30. Please let me know what works best.

I have attached a revised agenda that shows the day ending at 3:30 or 4:00 depending on whether the meeting with Nick is included.

She is particularly interested in hearing about distribution system planning and spending, including smart grid. She suggests dropping one of the tours, perhaps the transmission operations center tour, or possibly the "customer care" overview portion. I am not sure if maybe some of the customer care discussion might be focused on distribution, hard to tell.
