All –

Thank you for all of your work on the bill impact model over the past 3-4 months. Please find the link to SCE's bill impact calculator along with a separate NEM "plug-in" in the zipped file that can be run in conjunction with the larger model to estimate the impacts of tiered rate changes on NEM customers. To run the NEM model, simply download the files and unzip them into the same folder on your computer. Open both files and the NEM file connects to the larger OIR model.

An updated user manual can also be found on this site, which compliments a new "Help" button function in the model, which should answer most high level questions.

In summary the following major updates were made:

- □ □ □ □ Increasing baseline allocations to 60% per Sierra Club
- □ □ □ □ Additional NEM bill impact model that can be run in conjunction of larger model
- □ □ □ □ Updated the "Current" rates to reflect SCE's 2012 GRC Phase 2 structure per DRA

This model replaces any version used prior to today's date, March 11th, 2013.

On March 1, 2013 three parties emailed the service list with additional modifications or requests to include in SCE's model. DRA, DECA and Sierra Club each submitted individual documentation to address all IOU models. In addition to responding to each directly over the past week, SCE has summarized the requests and responses in the attached document. Many requests were already incorporated prior to this model, or have been incorporated in this version.
