QUESTION 7

Since its Petition for Declaratory Order dated April 29, 1996 in FERC docket EL96-48, has PG&E made any filings at the FERC pursuant to Federal Power Act Section 203 involving PG&E's transmission facilities? If so, please describe all such filings.

ANSWER 7

PG&E has been able to identify, in the limited time for responding to these data requests, the following PG&E filings at the FERC pursuant to Federal Power Act Section 203 involving PG&E's transmission facilities, since its Petition for Declaratory Order dated April 29, 1996 in FERC docket EL96-48, which was approved in a series of FERC decisions. See 77 FERC ¶ 61,204; 81 FERC ¶ 61,122. None of the Federal Power Act Section 203 filings identified below concern the transfer of operational control from PG&E to the CAISO, or *vice versa*:

- *Pacific Gas and Elec. Co.*, FERC Docket Number EC97-59-000: On September 29, 1997, PG&E filed an application pursuant to Federal Power Act Section 203 for FERC authorization to sell certain FERC-jurisdictional electric transmission facilities to Modesto Irrigation District, including certain transmission line segments and related facilities and land. On December 15, 1997, the FERC approved the sale of FERC-jurisdictional assets, with certain conditions. 81 FERC ¶ 62,199.
- *Pacific Gas and Elec. Co.; San Diego Gas & Elec. Co.; Southern California Edison Co.*; FERC Docket Number EC98-12: On October 27, 1997, PG&E, San Diego Gas & Electric Company, and Southern California Edison Company filed a Joint Application pursuant to Federal Power Act Section 203 to permit the use by the CAISO of portions of the Joint Applicants' communications infrastructure, power system monitoring and control systems, computers and computer software. On December 17, 1997, the FERC issued an order approving the Joint Application. 81 FERC ¶ 62,210.

- *Pacific Gas and Elec. Co.; Southern Energy Potrero, L.L.C. and Southern Energy Delta, L.L.C.*; FERC Docket No. EC99-38-000: On February 18, 1999, PG&E, Southern Energy Potrero, L.L.C. and Southern Energy Delta, L.L.C. filed a joint application pursuant to Federal Power Act Section 203 for authorization for PG&E to sell certain generation step-up transformers, related high voltage circuit breakers and generation tie transmission lines. On March 29, 1999, the FERC authorized the sale of the assets, subject to certain conditions. 86 FERC ¶ 62,248.
- *Pacific Gas and Elec. Co.; Geysers Power Co., LLC*; FERC Docket No. EC99-59-000: On March 31, 1999, PG&E and Geysers Power Company, LLC (“Geysers”) filed a joint application pursuant to Federal Power Act Section 203 for FERC authorization for PG&E to sell to Geysers generation step-up transformers, related high voltage circuit breakers and generation tie transmission lines, as part of PG&E’s divestiture of certain geothermal generating facilities. The FERC authorized the disposition, with certain conditions, on May 5, 1999. 87 FERC ¶ 62,139.
- *Pacific Gas and Elec. Co; California Indep. Sys. Op. Co.*; FERC Docket No. EC03-21-000: On November 25, 2002, PG&E and the CAISO jointly filed an application pursuant to Section 203 of the Federal Power Act requesting FERC authorization for the sale of certain transmission facilities to the Turlock Irrigation District (“TID”). The proposed transaction was part of a larger sale by PG&E to TID of certain distribution, substation and transmission facilities. PG&E proposed to sell to TID certain FERC jurisdictional transmission facilities including: (1) a 60 kV radial tap which extends from the CAISO-controlled grid to an end-use customer; and (2) a 60 kV line adjacent to a substation which was at that time part of the CAISO controlled grid. On January 3, 2003, the FERC authorized the transaction. 102 FERC ¶62,007.
- *Pacific Gas and Elec. Co.; Mirant Delta, LLC; Mirant Special Procurement, Inc.*; FERC Docket Number EC06-113-000: On April 17, 2006, Pacific Gas and Elec. Co., Mirant Delta, LLC, and Mirant Special Procurement, Inc. filed an application under Section 203 of the Federal Power Act requesting FERC authorization for disposition and acquisition of certain FERC-jurisdictional facilities, including interconnection facilities, tower structures and overhead conductors, a Generator Special Facilities Agreement, and associated accounts, books and records. On June 13, 2006, the FERC authorized the transaction, subject to certain conditions. 115 FERC ¶ 62,273.

In addition, on November 30, 2001, PG&E and its parent corporation, PG&E Corporation, filed with the FERC an application pursuant to Section 203 of the Federal Power Act for authorization to dispose of certain FERC-jurisdictional facilities. Docket Nos. EC02-31-000; EL02-36-000; and CP02-38-000. At the time, PG&E was a debtor

pursuant to Title 11 of the United States Code, and these filings were part of a plan of reorganization pending before the bankruptcy court. These filings were subsequently withdrawn.

Finally, although this filing was not made by PG&E, on July 18, 2006, the Edison Electric Institute (“EEI”) filed an application pursuant to Section 203 of the Federal Power Act for authority to engage in future transfers of FERC-jurisdictional facilities, in FERC Docket Numbers EC06-140-000 and EL06-86-000. The EEI’s filing was made on behalf of 39 FERC-jurisdictional signatories to the Spare Transformer Sharing Agreement, including PG&E.
