General,

Jane and I spoke this evening and we strongly recommend staying with the three panels. A lot of work has gone into the speaker arrangements, and we and the "Hall boys" think the diversity of panel topics and speakers is very attractive: (1) Culture and climate, (2) leading safety as a regulatory agency, and (3) elements of effective emergency response. Those are powerful themes (you set forth), and when you look at how they flow and the timing of the second day(830 to 1230) it seems to work well.

We talked today about panel moderators: Paul Clanon for the regulatory one wednesday morning and, as I mentioned, a media person for the emergency response one. The suggestion for the third -- culture/climate -- is Congresswoman Spier's chief of staff. The thinking is that could be a good way to have some balanced legislative representation/engagement.
