Given the very tight briefing schedule this month, with three briefs due in one month, and the number of intervening motions, meet and confer calls, and other events, the Division of Ratepayer Advocates (DRA), The Utility Reform Network (TURN), the City and County of San Francisco (CCSF), and the City of San Bruno (San Bruno) request the following extension schedule for the Fines & Remedies briefs due starting Friday, April 26, in the above-captioned proceedings:

- Intervenors and CPSD file Opening Briefs on Monday, May 6.
- PG&E files its Reply on Friday, May 24.
- Intervenors and CPSD file Rebuttal Briefs on Wednesday, June 5.
