**Purpose:**

Demonstration of our new electronic reporting system (through SAP) for gas asset maintenance. This tool enables electronic recording and auditing of the gas asset maintenance information that is currently kept in paper folders in the various PG&E Gas T&R yards. The new reporting system is an industry standard used for dispatching and scheduling work to mobile field service organizations. PG&E is in the process of implementing this system in 4 divisions, with the goal of transitioning the entire T&R organization by mid-2014.
